Fire Pay Bonus: Fire Bonus is additional pay, above regular-monthly salary, effective July 1st each year. The amount is to be calculated based on 20% of the total sum of Administrative Fees, as invoiced on all Out-of-District, Fire Wages.

No action at this time. Board directed staff to change the title from "Fire Pay Bonus" to "Administrative Processing Stipend" and place on future agenda.
